Judging Criteria: Artist may enter pieces in any or all of the following media: **Photography, Painting, Drawing, and Mixed Media.** All work must be: 1) original 2) well composed 3) well crafted.

Selection will be made from a CD or email to thompsonartists2@gmail.com. No original works will be viewed during the jurying process. Entry fee must be received before email entries will be considered. The images must be in jpeg format, at least 4 inches wide and minimum resolution of 300 dpi. Each image must be numbered with the initial of artist's first name and last name (i.e.: 01SJones.jpg) and must correspond to an included text, either in the email or Word or Rich Text Format (rtf) file listing the following information: item number, title, artist name, category and sales price or NFS.

Accepted Work: All work must be delivered ready for installation or hanging, (framed, wired, etc. [no saw tooth hangers]). Glass accepted for hand delivery, plexiglass ONLY accepted for shipped entries.

Notification will be sent to accepted artist. Removal of all accepted works must be according to instructions on acceptance notification.

Deliver accepted work to: 119th Street Artists' CornerStone Gallery, 1500 - 119th Street, Whiting, IN 46394.

Liability and Sales: Every possible care will be taken of all art work. 119th Street Artists assume no responsibility for loss or damage. Submissions of work for this competition will be construed as acceptance of all conditions printed on this prospectus.

119th Street Artists charge a commission of 20%
on all sales made as a result of this competition and the resulting exhibition.
